### Minutes of the Western and Pacific Region Leadership Council Meeting Kona, HI September 20, 2003

- 1. Sam Grossman, P. E., Sr. NSPE Western and Pacific Region Vice-President, called the meeting to order at 1:30 p.m. by welcoming all in attendance. Self-introductions of those in attendance were made in the morning before the Brainstorming Session. There were two guests from the Japan Society of Professional Engineers. Also in attendance was Teresa A. Helmlinger, P.E. the NSPE President and Mike Clark Executive Director of NICET.
- 2. Secretary Carducci called the roll and declared a quorum. (See Attendance sheet attached.)

- 3. MINUTES. The minutes of the January 18, 2003 meeting in San Francisco, CA were approved as submitted.
- 4. Chairman's Report. Sam Grossman
  - a. VIRTUAL MEMBERSHIP. This is a proposal by Mr. Grossman on behalf of the Western & Pacific Region to offer a free one-year membership to all newly licensed engineers in the United States. All the membership activities would be performed over the Internet web site. Newly licensed engineers would receive an email from NSPE offering them free, for one year, a virtual membership in NSPE. During the course of the year, these members would receive emails that would introduce them to the benefits of NSPE. All communication takes place over the Internet at significantly reduced cost. At the end of the year, we would send the member an invoice for the next year's dues. The States would lose income for one year. He anticipates a higher retention rate of these new members. Sam said that currently, NSPE spends over \$400 for each new member. The idea has been turned over to the Membership Committee. We will probably see a discussion at the Winter Meeting.
  - b. NSPE ENGINEERS REGISTRY. One of the Industry Groups attended by Past President Blitman discussed an idea that NSPE initiate an engineer's registry. This registry would contain verified information on registrants' background and qualifications that could be checked by potential employers. The NSPE

Membership committee is also studying this idea. This registry would be open to all degreed engineers as opposed to the NCEES Registry that is open only to licensed engineers.

- 5. Jr. VP's Report Eric Yamashige, P. E.
  - a. NSPE is discussing the level of support given to the regions. Marcia Pritchard will be assignd to the Regions from the NSPE Staff.
  - b. The States need to inform the Regional Vice-Presidents of the dates of their Annual Meetings so that the VP's can schedules their visits and avoid conflicts with other meetings. If a state wants the NSPE President or a representative at their meeting, they should make a formal request to national as soon as possible.

### 6. NSPE President Terry Helmlinger, P. E. Report

Terry reported on some of the items presented in the morning Brainstorming Session. She noted that eleven of the NSPE State Societies have administrators who also work for other societies in their states such as the ACEC. While not a formal merge, they are using a common office to reduce costs. This ties in with the idea of society merging presented in the am session.

NSPE has left the AAES again. She advocated this decision because she does not see the value for NSPE members. 2003 is a year that has seen five first women Presidents of Engineering Societies. At a meeting of these five women, they discussed ways for their societies to collaborate on issues of common interest. She doesn't see this happening effectively in AAES.

The coming Consensus Congress chaired by Bobby Price will not only refine the NSPE Strategic Plan but will also discuss where to make cuts in the NSPE Budget to reduce expenses and concentrate on core programs. These tough decisions need input from the membership.

She then reported on NSPE finances, the need for revenue enhancement, leadership development, and membership development through diversity and the Young Engineers Advisory Council.

Cliff Ishii said that if the local chapters are important, then NSPE should provide a staff person to support the chapters. Terry said that this year NSPE staffed a person to support the regions and maybe in the next budget consideration should be given to support for the chapters.

7. Japan Society of Professional Engineers (JSPE) – Sam Grossman, P. E.

Alan Werner presented a resolution asking the NSPE Board of Directors to direct the Products and Services Task Force to develop tools to enhance the profession of engineering to our members. It was moved and seconded to adopt this resolution. After discussion, an amendment the resolution was passed. CSPE will bill the W&PR the balance available and the Treasurer will pay it out of the '02-'03 Funds. The '02-'03 Financial Report was approved as amended.

The '03-'04 Budget was presented. Les Turnbeaugh presented the situation in California. Their financial position requires some adjustment in reimbursement received and services rendered. Currently they do not provide any support. Eric is exploring the services to be received from the assigned NSPE staff person. Sam suggested that we provide a budget of \$5,000 to CSPE for services.

- 12. Nomination and Election of the W&PR representative and alternate to the NSPE Nominating Committee for 2004-05.

- 14. There were no Administrative/Finance, Regional Planning or Communications Committee Reports.
- 15. The Chairman of the Convention Committee for the July 2004 NSPE Summer Meeting in Honolulu, Hawaii is Ken Rappolt, P.E. The Legacy Project for that meeting will be the Hawaii Habitat for Humanity. They plan to construct a house and raise \$20,000. The venue for the meeting is the Ilikai Hotel. There will be opportunities to travel to the outer islands before and after the meeting. The Chairman says, "Two trips to Hawaii within one year are perfectly acceptable."

- ·In all matters of local concern, the Affiliated Group shall have full autonomy but may call upon NSPE for advice, counsel, and assistance.
- ·The Affiliated Group shall have no representation on the NSPE Board of Directors, but may attend all NSPE Board of Director Meetings.
- ·JSPE and NSPE shall continually explore opportunities for mutual cooperation to enhance the affiliation.

Based on this agreement, JSPE would attend WPR meeting and would like to form a lasting relationship with NSPE and WPR.

Whereas: Membership in NSPE and most state societies is declining;

Whereas: The average age of NSPE membership is increasing;

<u>Whereas</u>: The attitudes of younger engineers are different than those of older engineers with respect to association membership;

<u>Whereas</u>: A common perception exists that NSPE does not offer deliverables in the form of tangible benefits as products and services of interest to members and potential members; and

<u>Whereas</u>: Goal 3 of the NSPE Strategic Plan states "Provide education, career development, networking opportunities, and other benefits to engineering professionals and students."

<u>Resolved</u>: That the Western and Pacific Region should bring before the NSPE Board of Directors a Resolution directing the Products and Services Task Force of the Society to adopt the following policy:

NSPE should endeavor to solicit, produce, deliver, and promote those tools, courses, materials, and techniques that will enhance the profession of engineering to members and potential members as a prime goal of the Society. The delivery of these products and services should be multi-modal, may not be exclusively NSPE property, and should begin within six-months of presentation to the NSPE Board of Directors
